- Willing for their solutions to undergo a performance assessment by ArianeGroup or MaiaSpace.

B2B meetings will be proposed based on the following criteria:

- Alignment of the proposed technology/solution with the ArianeGroup or MaiaSpace's topics of interest.
- Degree of innovation and differentiation compared to existing solutions on launchers.
- Maturity consistency with respect to the introduced innovation level
- Development effort relative to the expected benefit.
- References if any of the proposed technology/solution, with Space Agencies.

Procedure:

Interested SMEs and Start-Up sare encouraged to express their interest by applying before 25/10/2024. Successful applicants will be invited for B2B meetings to be held during the last week of November. These meetings will be grouped by scopes and will either be hosted at ArianeGroup facilities or online, based on a minimum travel best fit.

Scheduled dates for topic-based meetings are as follows:

26/11/2024 Thermal & Mechnical products & Data in production

27/11/2024 Propulsion subsystems & Assembly Integration and Test

28/11/2024 Avionics (Sensors) & Manufacturing

29/11/2024 Functional and Ground Equipment & Supply Chain

Frequently asked questions

Who do I submit my proposal to?

Your EEN or Network contact is your interface up to ArianeGroup or MaiaSpace selection. You must send him/her the filled OnePager form by E-mail before 25/10/2024.

Can I obtain clarifications to issue my proposition?

YES, you can ask your EEN or Network contact to obtain answers on the process. If the answer is not issued in the provided documentation, then it is likely to be distributed to all potential applicants. Technical questions should be limited. They will be transferred to ArianeGroup / MaiaSpace in a dedicated single E-mail address.

What is the language to be used for my application?

The communication language for the written exchanges is English (preferred) or French. It deals with the OnePager form to be filled.

How will be used the information I will submit?

The written OnePager form will only be used for the purpose of the selection of SMEs and Start-Ups for the B2B meetings.

It is not foreseen to exchange confidential information during the B2B meetings with the selected SMEs and Start-Ups. Actually, the objective is to identify new potential partners in Research & Technology Development activities in a 45 minutes time slot. However, a Non-Disclosure Agreement can be issued if needed on a case by case basis.

How will I know I am selected?

The selected SMEs and Start-Ups will be contacted directly by ArianeGroup or MaiaSpace from the 20/11/2024.

In case of negative answer, your Network contact will inform you of the result.

How will be organized the B2B meetings?

The selected SMEs and Start-Ups will have an invitation from ArianeGroup or MaiaSpace by E-mail with a proposition of meeting location and time slot. They will have to confirm their attendance and on site or online meeting preference. The meeting should last 45 minutes and address a context explanation on the topic by ArianeGroup or MaiaSpace relevant representatives, a pitch from the SME/SU, clarification questions, feedback and way forwards.

Is there any travel fees for the meetings in Les Mureaux?

No. The B2B meetings location will be hosted at ArianeGroup facilities or online, based on a minimum travel best fit. The selected SMEs and Start-Ups will be asked their preference.
